TERMS AND CONDITIONS OF SALE OF SITES AT ACHITNAGAR LAYOUT

- 8. Any bids made below the reserve price in respect of sites where reserve price is fixed shall be rejected forthwith.
- 9. The intending buyers shall be allowed to inspect the properties, verify the property documents, only during the period (dates and time) specified in the schedule. - 13. The Sealed Bids for sale will be opened in the presence of bidders present, on the scheduled date and time. After opening of the bids only top 3 highest bidders will be allowed to participate in inter-se bidding. Opportunity for inter-se bidding will be given to enhance the bid amount in multiples of Rs.500/- per Sq. Ft. The bidders are advised to be present personally on the date of opening of the sealed bids on the scheduled date and time.
- 14. Where there are only two bidders for any site both such bidders shall be allowed to participate in the inter-se bidding.
- 15. The successful bidder shall pay the full and final Sale consideration within 15 days from the date of the Sale being knocked down or from the date of acceptance of offer by the company. EMD amount shall be forfeited if the successful bidder fails to pay the full Sale consideration after adjusting the EMD, within the time specified and the defaulting buyer shall forfeit all claims to the site.
- 16. The confirmation of sale of site(s) shall be handed over to the successful bidder only on receipt of full and final sale consideration.
- 17. All the legal/ incidental expenses such as stamp duty, registration fees, local taxes, transfer charges and all other levies, charges, cesses and other incidental charges shall be borne by the buyer(s) only.
